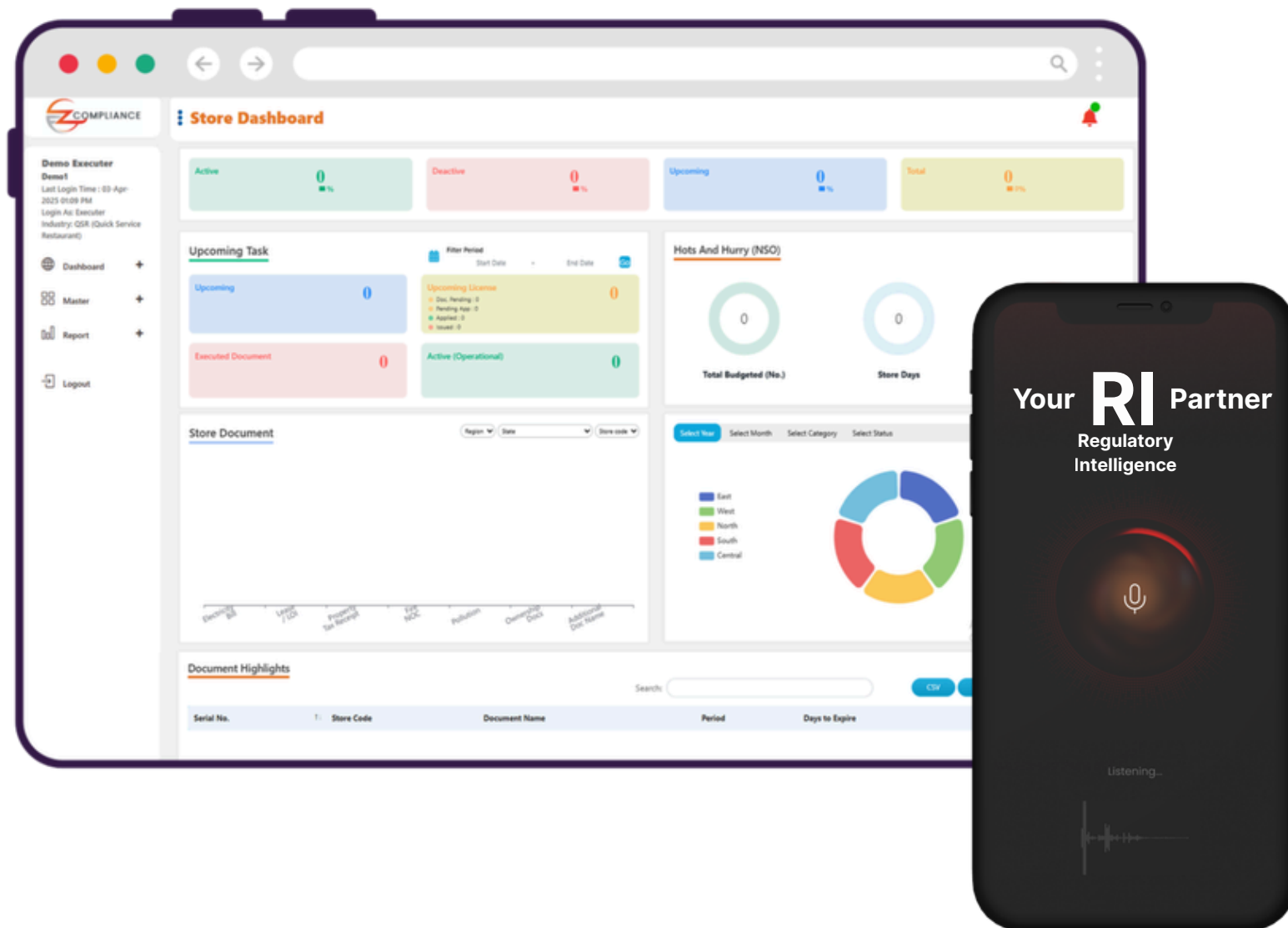
- **Non-compliance** red flags during due diligence and audits

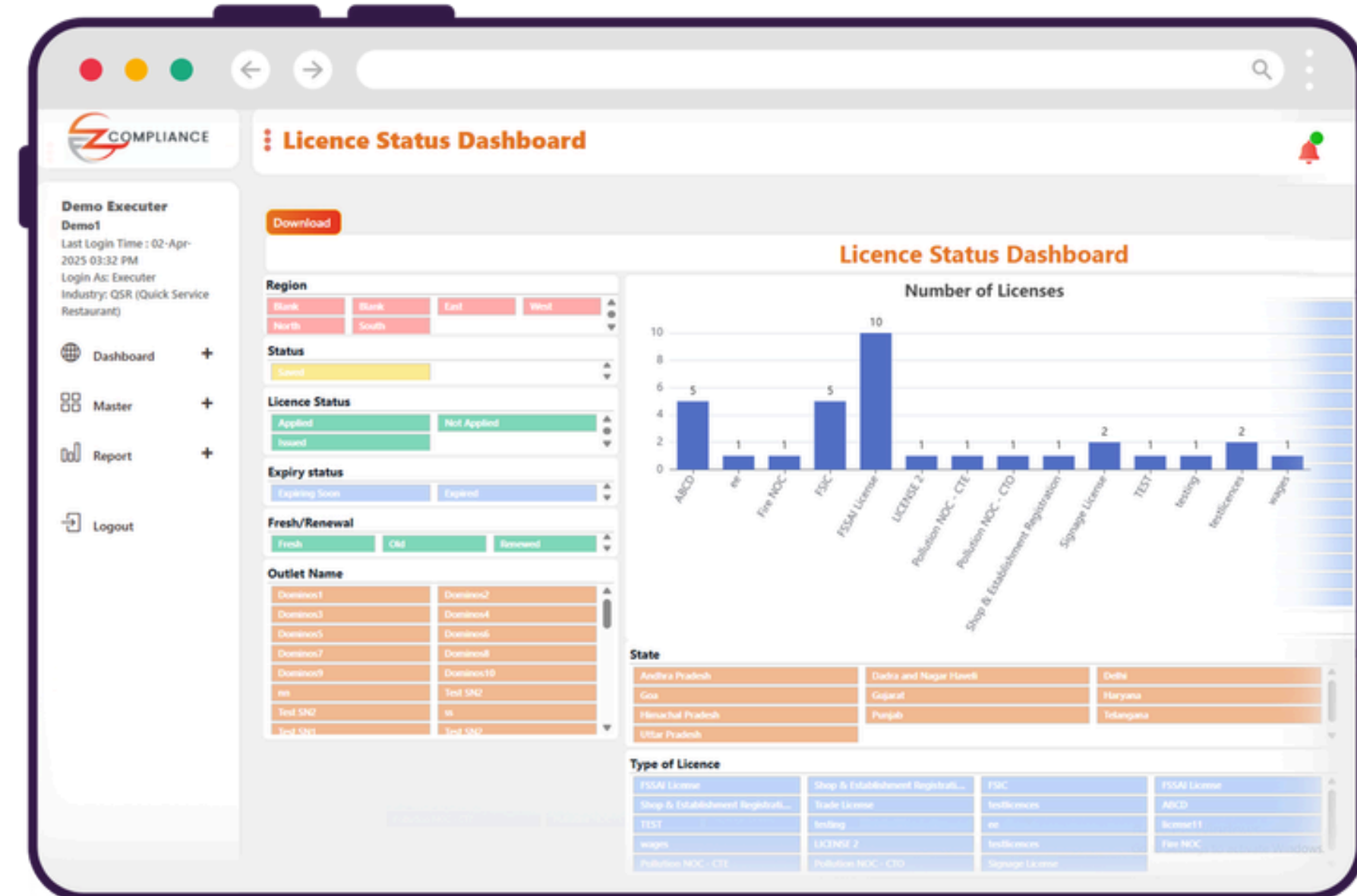

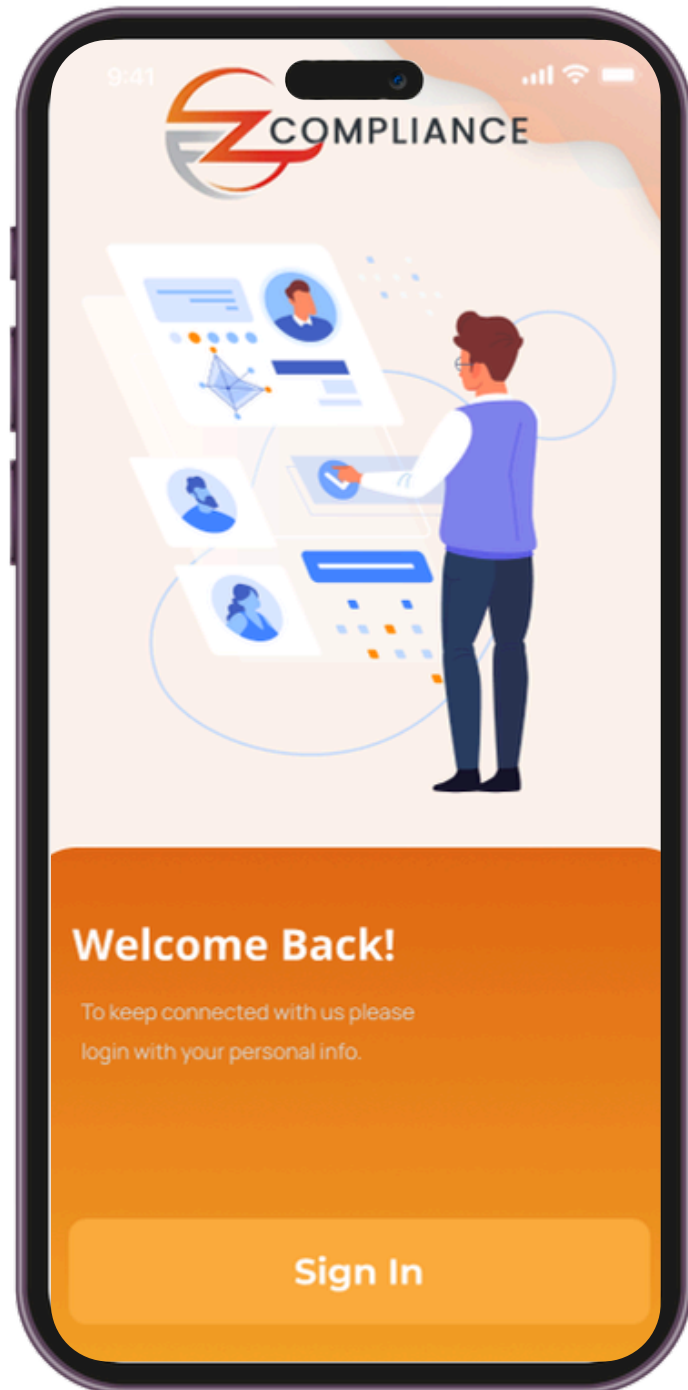
